Research & Innovative Practice Grant Application

TSAHP announces the 2025 Research & Innovative Practice grant cycle. Up to three (3) \$3,000 grants will be awarded to support scholarly activity in the health professions in the areas of health care quality, education, procedures and techniques, and outcomes.

Eligible applicants must be health professions faculty affiliated with a health professions discipline at a college or university that is an institutional or association member of the Texas Society for Advancement of Health Professions. Projects should in some way touch on and be influenced by health profession disciplines, education, or clinical areas. Award recipients are expected to:

- Provide a mid-year progress report to TSAHP by March 31, 2026, and
- Make an **oral presentation** of their results at the 2026 TSAHP conference
- **Applications** must be received by midnight, **April 30, 2025**, to the TSAHP portal at the link noted below. The contents of the proposal and its attachments are listed on the following page.

Proposals that exceed five (5) pages in length will <u>not</u> be reviewed; this limit excludes the Cover Letter, Bio sketch(es), Cover Page, and Abstract. The packet must include all documents to be considered complete and eligible. Documents may be single spaced and must use Arial 12-point font, 1-inch top and bottom margins, and 1.25-inch left and right margins. To facilitate blind review, authors' names and institutional affiliations must be omitted from the Abstract and Proposal. While totally blind review may not be possible given parameters of some projects, we request compliance as much as possible.

The application must include the following. Incomplete applications will not be considered.

- 1) **Cover Letter** (one page): The principal investigator (PI) must provide written assurance that IRB approval has been or will be obtained prior to the disbursement of funds to the award recipient(s).
- 2) Bio sketch (one page for each author): The bio sketch does not need to be in NIH format, but should list the individual's name, position title, institutional affiliations, education and training, and qualifications to fill a specific role in the proposed project. The bio sketch may include a personal statement, prior positions and honors, contributions to science, and additional information including research support and/or scholastic performance.
- 3) **Cover Page** (one page): Lists the project title, and the name and institutional affiliation of each author; designates clearly the phone number, email address, and mailing address of the corresponding author.
- 4) **Abstract** (one page): Includes the project title and summarizes all components of the proposal.
- 5) **Proposal** (no more than five (5) pages) must include the following:
 - a) **Background:** States the problem or purpose of the research or innovative practice project and specifically indicates the significance and relevance to allied health professions.
 - b) **Review of Literature**: Provides an overview of related literature pertinent to the project.

- c) **Research Design/ Method or Plan for Innovative Practice Project:** Describes the research approach or implementation plan for the innovative practice project and the plan for analysis/evaluation.
- d) Budget: Details how funds are to be used and whether this proposal is stand-alone, requests partial funding, or complements an existing project. All funds must be expended in direct support of the proposed investigation; awards may not be used for payment of indirect costs to any institution. Note: Travel is limited to 20% of the total award and may be used for travel to present research findings/innovative project at the TSAHP conference.

Criteria used to evaluate proposals will include:

- 30% **Justification for the project**: Explanation of background, purpose, significance and relevance to allied health, including overview of current literature pertinent to the project
- 40% **Research design or practice plan**: Appropriate to the purpose, comprehensiveness of implementation plan, methods to be used including sampling, instrumentation, specific procedures, and analytic strategies
- 20% **Budget**: Logical explanation and justification for use of funds which meet outlined criteria
 - 10% **Quality of proposal**: Overall clarity, organized approach, terminology, and grammar

SUBMIT completed research grant application and letter of intent (optional) to: <u>TSAHP Online Portal</u>. Individuals must have a Google account to submit their grant application.
